2 INNOVATIVE LEARNING

In today's changing policy landscape, the world is becoming a global village. The School of Public Affairs collaborates with a network of partners to prepare the next generation of global village leaders to understand and to create solutions to global public policy challenges. The School's mission is to help responsible actors to think critically about complex policy issues, to design concrete solutions and to transform ideas into action.

Case studies use active pedagogy, placing students at the heart of complex situations. Students are immersed in the retrospective analysis of a case and work together to find practical solutions to the problems raised.

Student-led policy simulations, such as the European Heritage Prize and the Paris Energy Simulation constitute innovative educational projects that aim to place students in real-life professional situations.

The Policy Innovation Lab enables students to engage in a project related to a major public policy issue, to propose concrete and innovative solutions and to implement these solutions in order to improve the lives of citizens. The Lab mobilizes students to develop creative technological and policy solutions to challenges related to the UN Sustainable Development Goals (SDGs).

The School of Public Affairs partners with Harvard and the Centre de recherches interdisciplinaires (CRI) to offer students from these three prestigious institutions a Summer School which combines hard sciences and social sciences. This summer programme explores the links between biology, engineering, design and social sciences in order to transform local public policies through a focus on citizen engagement.

Civic Tech Initiative, a partnership with the School of Public Affairs, Facebook, Make.org Foundation and *Les Echos* magazine, draws together technological innovation and citizen engagement to transform citizens' ideas into concrete political impact.

The Master in Public Policy is a two-year degree designed to prepare future professionals of public affairs for a great diversity of careers worldwide.

The curriculum is built around a thorough core module in public economics, public policy, ethics, technology, management, international governance and law, with a choice of a multitude of electives that examine current policy debates with insights from academics and practitioners.

MASTER IN PUBLIC AFFAIRS

The Master in Public Affairs (MPA) is Sciences Po's flagship full-time one-year programme for mid-career professionals interested in public policy and the interaction of the public and private sectors.

The programme focuses on policy design and implementation as well as on the management of public affairs, and introduces participants to real-world policy problems using interdisciplinary analytical tools and hands-on training workshops.

The MPA relies on Sciences Po's world-class faculty and its unparalleled network. It engages the alumni community for guiding student projects, for master classes and students' career development.

The MPA's other advantages include innovative teaching strategies (online resources, project work, policy lab), small group size, and international diversity of students and faculty.

In addition to fostering students' analytical capacity, the MPA also focuses on management in all its dimensions: negotiation, crisis communication, regulation, digital transformation of organisations, decision making and public budgeting.

THE EXPERIMENTAL PROGRAMME IN POLITICAL ARTS

The Experimental Programme in Political Arts (SPEAP) is a one-year Master's programme for mid-career professionals with at least 4 years of professional experience.

This full-time programme brings together architects, designers, academics, public servants, managers, researchers, administrators, activists and curators who wish to enhance their skills, develop inventive tools and give new momentum to their career.

This multidisciplinary programme is driven by key notions of experimentation, inquiry and innovation that explore the points of articulation and connection between scientific, artistic, and political fields. The programme's conceptual framework is based on the fields of social sciences and humanities (including philosophy, sociology, history and science). The programme combines theoretical teaching with pragmatic tools and concepts, through group work and workshops that are comprised of exercises in which participants co-develop and test practical solutions to real-world issues.

Students will also benefit from the core curriculum of the School of Public Affairs. According to their professional trajectory and objectives, students can choose to develop skills in project management within the scope of public policy and the various policy streams offered within the School.

With an emphasis on the nexus between the political and economic spheres as they relate to mutating defence and security challenges, this policy stream will focus on the methods used to construct and administer policies within civil and military institutions.

It equips highly skilled economists with rigorous analytical and quantitative knowledge and professional skills applied to a variety of policies from competition policy and regulation, monetary, financial and fiscal policy to employment and social policy.

This stream particularly equips students to pursue careers related to economic policy making in governmental organizations, international organizations and public agencies. It also meets the needs of highly trained economists working in the private sector, for instance in banking, consultancy, public-private partnerships or non-governmental organizations.

A new area of public affairs is calling for a new kind of manager of public affairs. A new awareness of individuals and groups is forging a new public policy paradigm, where the frontiers between public sector, private sector, organizations and civil society are blurred. To evolve between those different layers, from the local to the global perspective, from public-private partnerships to organization and civil society, new skills are required for managers of public affairs.

MARKETS AND REGULATION

Whether at European or national level, graduates of this policy stream should be competent to ensure that the policies are efficient and effective. It is designed to prepare the students to be competent in policy-making with a perspective on how policies are affecting the everyday life of business and citizens.

The curriculum connects theory and practice by providing the necessary multidisciplinary approach to deal with regulatory policy problems. Students receive professional expertise through case workshops, elective coursework in specific fields of regulated policy areas both at national and European level such as Energy and Environment Policy; Health and Social Policy; Sustainable development and European Monetary, Fiscal and Financial Policy.

POLITICS AND PUBLIC POLICY

This policy stream in Politics and Public Policy offers an excellent preparation for further research work or for work in public sector, policy analysis and consultancy, European institutions, non-governmental organizations and the private sector. Students learn political processes and institutions in democracies and non-democracies around the world with a special focus on the European continent.

Throughout the stream focus is both on national and European politics.

The stream gives students both a specialization in a subfield of political science and rigorous research training.

In France, top-level civil service positions are accessible only to those applicants who have passed competitive examinations and joined a dedicated school of public administration.

One of the most prestigious schools, leading to the highest positions in the public administration, is the National School of Administration (ENA).

Other schools are more specialized and grant access to foreign affairs, public health functions, the parliament's administration, etc.

They recruit among the best graduates through highly competitive exams.

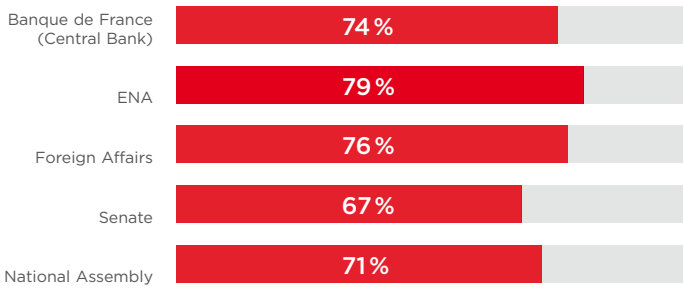

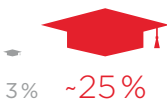

PREPARATION CENTRE FOR EUROPEAN CIVIL SERVICE

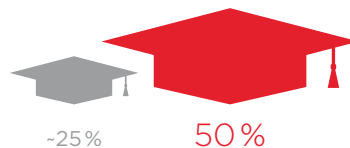
The preparation center for European civil service examinations at Sciences Po prepares participants for the AD5 (Administrator) competitive entry examination of The European Personnel Selection Office (EPSO).

The preparation is available in both French and English, and combines online and in-class modules. Among registered participants in this programme, 20 to 25% pass the eligibility step (<3% overall) each year, 50% of whom are admitted (~25% overall).

EXECUTIVE PROGRAMMES

The School of Public Affairs offers a set of training programmes for experienced professionals who wish to navigate across the borders between the public and the private sectors, civil society and politics, and between the regional national and international levels.

Relying on its strong and diverse faculty, the School offers different types of programmes:

- Tailor-made programmes are developed together with Sciences Po Executive Education for public and private institutions looking to build their capacity. The functioning of the EU, public management, policy analysis and reform implementation are among the elements at the core of our programmes. The School of Public Affairs also draws on the expertise developed within its policy streams (digital and public policies, energy and sustainability, culture, etc.) to offer advanced training in those areas. Among recent realizations are a Training Programme for Indian Administrative Service (IAS) Officers, or an executive certificate in Management and Public Policy for young civil servants from the Western Balkans. The latter was funded by the European Commission.
- The open enrolment Executive Programme on European Public Policy and Management, in partnership with the Hertie School of Governance in Berlin, LUISS University in Rome, and King's College in London has been developed for top civil servants at national levels and in Brussels and prepares them to build intergovernmental and supranational cooperation in Europe.
- A part-time *"Executive Master en Management des Politiques Publiques"* (in French) and a full-time 1-year Master in Public Affairs complete the offer of executive programmes.
